## >>> BACKGROUND

istorically, Nigerian women are recognized for playing significant roles in all stages of the country's development.. Since the 19th Century, records of women's outstanding contributions to national development have been in existence; so are documentation of their struggles in advancing the rights of women and girls. This has resulted in the formation of women's movements in the country. The present-day Nigeria has witnessed the multiplicity and specialization of women organizations who have developed activities around addressing negative social issues such as Sexual and Gender-Based Violence, Women Political Exclusion Women Economic Dis-empowerment, Sexual Reproductive Health and Rights, Maternal Mortality, and Child Marriage to mention a few. Over the centuries, concrete evidences have revealed that the active involvement of women in the social and political landscape helped to improve their status at the grass-root, national and regional levels.

Despite recording landmark achievements in the activism for gender equality, unequal power relations resulting in disproportionate distribution of rights and privileges to women has been a cause for concern. Issues such as unequal participation in politics for women, non-domestication of international instruments that protect women and girls especially CEDAW, weak implementation of laws made to promote the rights of women, and rising injustices against women and girls threaten and overshadow the progresses made in the women's rights space.

The growth and diversity of women's rights movement in Nigeria, however, does not come without its challenges. Fragmentation is one main factor that undermines their effectiveness; geographic, thematic, religious, and political affiliations often result in organizations that -narrowly focus on their own objectives rather than on a broader women's rights movement objectives. In addition to this, many of the organizations have limited resources and weak capacities for effective programme implementation.

Funding has been identified as a major challenge for the advancement of gender equality and empowerment. For example, interventions to raise consciousness on, and respond to GBV issues and other discriminatory practices like sexual violence, domestic violence, harmful widowhood practices such as denial of inheritance rights and Female Genital Mutilation, and trafficking in persons require funds.

Although a number of women's rights organisations and coalitions have benefitted from Donor Funding, Donor's funding priorities are usually thematic based and mostly designed to suit the donor's mandate, thus restrictive with no flexibility for taking on issues considered a priority by local women's groups.


Additionally, some donor's funding targets established organizations, and this excludes organizations with relative capacity - despite their passion and commitments to grass-root change. It is against these backdrop that the Women's Voice and Leadership Nigeria Project is designed to primarily break the two major barriers in donor funding architecture - inaccessibility and non-flexibility of available funds for women's rights organisations in Nigeria.



## >>> THE WVL-NIGERIA PROJECT


he Women's Voice and Leadership Nigeria (WVL – Nigeria) project is a five year project that is being funded by Global Affairs Canada. The project is building the capacities and supporting activities of local and national women's rights organisations and movements who seek to empower women and girls, advance the protection of women and girls' rights, and achieve gender equality in Nigeria. Through this project, ActionAid Nigeria has re-defined the narratives of Donor funding by establishing partnerships with 118 women's rights organisations who have the privilege of accessing funds which allows them the flexibility of implementing their respective core mandates as women-focused organisations.

The project provides multiple layers of funding and tailored capacity building to support these organizations. Apart from funding, partners have access to tools, resources, and mentorship opportunities which further strengthen and sustain their financial, technical, and organizational capacity in advancing the rights of women and girls and addressing gender equality barriers more effectively. Additionally, the project supports feminist platforms at the state and federal levels for more effective networking and greater cohesiveness in the advancement of women and girls' rights.



Since its inception in April 2019 and full commencement in July 2019, the project has been funding the implementation of impactful activities around **Gender-Based Violence**, **Women Political Participation**, **and Economic Justice** in eighteen (18) states of Nigeria and the Federal Capital Territory. To ensure a geographic balance, the project states were selected to represent the 6 geopolitical zones of Nigeria.


## >>> LAYERS OF FUNDING

#### 1. The Multi-Year Grant


This is a 5-year predictable funding arrangement that supports the core mandates of 100 Local Women's Rights Organizations (LWROs) and Networks at the community, state and national levels throughout the project duration. This provision allows beneficiary organizations to continue implementation of on-going or new interventions, and to address core institutional needs of the organizations. The grantees have used the funding on policy influencing, service delivery, advocacy and sensitisation, feminist research, campaign interventions as well as, improving organizations infrastructure development.



AAN used a robust selection process for contracting the beneficiaries of this funding which includes mapping of women's rights organizations to provide a database as a starting point for engagement, an open call for local women's rights organizations to apply for funding through a simple Expression of Interest process, conduct of background check on these organizations and finally, a Partnership Assessment and Monitoring Exercise that allows for development of capacity building plans for system strengthening purposes.



For grassroots impact, the project selected 72 Community-Based organisations from the 3 senatorial zones of each project state with a distribution of 4 CBOs per senatorial zone. For ease of coordination given the substantial number of CBOs, one state level partner with demonstrable capacity for grant management in each project state manages the granting process of CBOs in each state. This also allows for the strengthening of the subgranting capacities of the selected state level partners.




#### 2. The Strategic Innovation Fund (SIF):

This Fund is available throughout the life cycle of the WVL-N project. It is designed to support emerging innovations and new initiatives from women's rights organisations, networks, and movements. It is especially exciting because it is also accessible to women's rights organisations who are not benefitting from the multi-year grant. The flexibility of the grant lies in the fact that it is not restricted to WVL-N project states.

The SIF is available to be accessed on an annual basis. Since the launch of this grant stream in March 2020, it has benefitted five (5) women's rights organisations with innovative ideas which can serve as a catalyst for new ways of doing things within the Women's Rights movement in Nigeria.

The Call for Proposals for the SIF opens every April through which applicants are expected to provide a brief concept note outlining their innovative ideas. The timeline from announcing the call to the selection and awarding of the grants is not more than three months.

### 3. The Strategic Opportunity Fund (SOF):

The grant allows Women Rights Organisations (WROs) to be agile in responding to women and girls' rights issues. It is set up as a rapid response fund that can be quickly accessed by women's rights organizations. This grant enables WROs and their movements respond promptly to rights violations, or to seize opportunities to create change in the lives of women and girls across the country.

The uniqueness of this grant is that it does not follow the long grant award continuum - call for proposals, proposal development, review, pre-selection, due diligence, final selection, Work Plan development, and Work Plan Approval, and Funds Transfer- but rather a simple and speedy process of not more than 24 hours response from receipt of applications from women's rights organization and not more than 7 days for project implementation and funds liquidation. To achieve this, the Grant Selection Committee adopts a virtual approval process for awarding of grants.

To access this fund for an emerging issue of rights violation, applicants must take into consideration the following factors:

- The impact of the action on the rights of women and girls
- The envisaged changes/results the action will have on the lives of women and girls.
- The multiplier effects of the intervention on a national scale
- The broader contribution of the intervention to the achievement of gender equality.

#### 4. **COVID-19Top-Up Fund**

The COVID 19 pandemic took the world by surprise. Most worrisome is the rise in sexual and gender-based violence. To mitigate the impact of the pandemic on women and girls, Global Affairs Canada introduced this new short-term grant stream. This created an opportunity to further support existing and new partners with experience in the provision of protection interventions for women and girls.

The grant is a one-off fund channelled towards the provision of critical protection services for vulnerable women and girls within and Post Covid-19 Period in Nigeria. It is a small grant designed to support WROs to implement actions that will lead to women and girls living in reduced violence or fear of violence by supporting victims and survivors of gender-based violence to access protection services.

In total, 7 existing partners and 13 additional women's rights organisations were selected and granted for a 6 months period to implement protection services.

#### States of Implementation

Services provided under this grant stream include legal aid services, short-term shelter services, evacuation and/or escort services, medical support, psychosocial support, and emergency support to indigent women and girls, women with disability and elderly women. In addition, the fund also supported actions such as consciousness building using traditional and new media, evidence gathering on Violence Against Women and Girls (VAWG), and advocacy for implementation of VAWG related legislation.
